ABOLITION OF KANDEP RURAL LOCAL-LEVEL GOVERNMENT IN ENGA PROVINCE

I, JOB POMAT, Acting Governor-General, by virtue of the powers conferred by Section 28 of the Organic Law on Provincial Governments and Local-level Governments and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after considering a recommendation by the Minister for Inter-Government Relations, hereby approve to abolish Kandep Rural Local-level Government with effect on and from 16th December, 2021.

WHEREAS SECTION 27(1) OF THE ORGANIC LAW ON PROVINCIAL GOVERNMENTS AND LOCAL-LEVEL GOVERNMENTS PROVIDES THAT THE HEAD OF STATE, ACTING ON THE ADVICE OF THE NATIONAL EXECUTIVE COUNCIL, MAY, BY PROCLAMATION, ESTABLISH A LOCAL-LEVEL GOVERNMENT IN AND FOR THE AREA DESCRIBED IN THE PROMCLAMATION.

NOW THEREFORE, I, JOB POMAT, ACTING GOVERNOR-GENERAL, BY VIRTUE OF THE POWERS CONFERRED BY SECTION 27(1) OF THE ORGANIC LAW ON PROVINCIAL GOVERNMENTS AND LOCAL-LEVEL GOVERNMENTS AND ALL OTHER POWERS ME ENABLING, ACTING WITH, AND IN ACCORDANCE WITH, THE ADVICE OF THE NATIONAL EXECUTIVE COUNCIL, GIVEN AFTER CONSIDERING A RECOMMENDATION BY THE MINISTER FOR INTER-GOVERNMENT RELATIONS, DECLARE LAI RURAL LOCAL-LEVEL GOVERNMENT WITHIN KANDEP OPEN ELECTORATE, AS A RURAL LOCAL-LEVEL GOVERNMENT, AND I DO FURTHER DECLARE THAT:—

- (a) The Boundaries of Lai Rural Local-level Government shall comprise of the Wards as described in the Schedule to this Proclamation.
- (b) The said Rural Local-level Government shall be divided into twenty-two (22) Wards.
- (c) The said Rural Local-level Government shall be constituted of twenty four (24) Members of which twenty-two (22) Ward Councillors are elected one to each Ward and two (2) are nominated in accordance with Section 29(1)(d) of the Organica Law on provincial Governments and Local-level Governments.
- (d) The said Rural Local-level Government shall come into operation on 16th December, 2021.

- (d) The said Rural Local-level Government shall come into operation on 16th December, 2021.
