PRESS STATEMENT

The Electoral Commission by way of publication in the National Gazette on 06 May 2022 appointed Mr Willie Ropa as the Returning Officer for the Hagen Open Electorate. However, there was another Gazette with the same description that had Mr. Amos Noifa's name as the Returning Officer. The member for Hagen Open Hon. William Duma on the basis of these two different appointments filed Court proceeding in the National Court where he sought for Mr. Amos Noifa to be declared by the Court as the Returning Officer for Mt. Hagen Open Electorate.

On 12 May 2022, the National Court granted an application by Hon. William Duma where interim restraining orders were made restraining myself and Mr. Willie Ropa from interfering with Mr. Amos Noifa in the performance of his functions as the Returning Officer for Mt. Hagen Open Electorate.

I have filed an appeal against the grant of the restraining orders in the Supreme Court. Pending determination of the appeal, I filed an application to stay the restraining Orders granted by the National Court and I would like to advise the public, intending candidates and stakeholders in Mt. Hagen that this morning at around 9:00 am, the Supreme Court granted the stay application and made an order staying the restraining orders of 12 May 2022 granted by the National Court – which in effect authorized Mr Amos Noifa to act as the Returning Officer for the Mt. Hagen Electorate. A consequential order was also made for Mr. Noifa to return all the nominations already made to him, to the duly appointed Returning Officer, Willie Ropa before 4:00 pm this afternoon.

For clarification to the general public, the issue of who is the legally appointed Returning Officer for the Hagen Open Electorate still remains in Court. However, in the interim and in the interest of justice, the Supreme Court has stayed the National Court orders and the proceeding, the net effect of which is that Mr Willie Ropa remains the duly appointed returning officer for Hagen Open Electorate, as per his appointment. Amos Noifa has also been instructed to return all nominations to Mr. Willie Ropa, as directed by the Court.

I appeal to the people of Western Highlands and Mt. Hagen to remain calm respect the processes in place as my office is doing its best to ensure that the elections for the Mt. Hagen Open are conducted openly, freely and fairly
